# PRIVACY AND COOKIE POLICY

Naschitz, Brandes Amir & Co., Advocates' privacy policy (the "**Privacy Policy**" or "**Policy**") explains our practices for processing Personal Information on our Website.

We are an Israeli law firm, and as such Israeli law applies to our services and our data processing activities. You do not have a legal obligation to provide us with any Personal Information through this Website. Any Personal Information provided to us is your choice. However, without receipt of Personal Information it may not be possible to contact you or to provide you with certain services.

Please read this Policy and make sure you fully understand our practices in relation to your Personal Information, before you access or use the Website. If you read and fully understand this Privacy Policy, and remain opposed to our practices, you must immediately leave this Website, and avoid or discontinue all use of the Website. #### **Definitions**

- "NBA", the "Firm", "we", "us", "our" shall mean Naschitz, Brandes Amir & Co., Advocates, a registered partnership, incorporated and existing under the laws of the state of Israel, having its principal place of business at 5 Tuval Street, Tel-Aviv, Israel.
- "Personal Information" shall mean any information that identifies, relates to, describes, is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular individual, or as otherwise defined as such in applicable laws.
- "Terms of Use" shall mean the terms and conditions which govern your use of the Website [HYPERLINK].
- "Visitor", "user", "you", "yours" shall mean an individual person who browses our Website, contacts us through the Website or provides information through the Website.

## Personal Information you may provide us through the Website and Purposes

We collect Personal Information you voluntarily provide us on the Website.

- We collect Personal Information about you when you voluntarily contact us through the communication means listed under the "Get In Touch" tab on our Website, including by phone, e-mail, through our LinkedIn or Facebook pages hyperlinked on the Website or otherwise. - <u>Purposes of use of Personal Information provided by you through the Website</u>: We process and use the types of your Personal Information listed in Section 2.1 for the following purposes:

  choose whether or not to provide or disclose Personal Information and please do
  not provide any more Personal Information than is needed for us to contact you.
- to provide, operate and maintain the Website;
- to monitor and analyze use of the Website and study and analyze the functionality of the Website;
- to enforce our Terms of Use, policies and other contractual arrangements and prevent misuse of the Website;
- to comply with court orders and warrants and to take any action in any legal dispute and proceeding;
- if you have subscribed to our newsletter we may use your email address, which you provided us, in order to send you our newsletters. At any time, you may opt out by clicking "unsubscribe" at the bottom of our emails or by contacting us at: info@nblaw.com.
- Personal Information you may provide us if you are a candidate for a position in the Firm:
  - We collect Personal Information about you when you voluntarily send us your CV
    and other documents containing Personal Information, . In addition, we may receive
    Personal Information about you from recruitment agencies or when conducting any
    assessment tests, as well as from previous employers.
  - We process and use this type of your Personal Information in connection with your job application, for evaluating your suitability for relevant positions, contacting and communicating with you and your references (which you provide us), and retaining your information for future employment opportunities, if applicable. We may also use this Personal Information to protect our rights and comply with our obligations.
- If you provide us Personal Information about others or consent to our processing of third party Personal Information on their behalf, you must do so in compliance with applicable law and verify that such third party is aware of this Privacy Policy and its terms.
  - We may create anonymized, aggregated and statistical information from Personal Information you provide us through the Website in order to further develop, customize and improve our Website based on Visitor preferences, experiences and difficulties.

# Personal Information we collect or generate through the Website

When you visit our Website we use technological tools (detailed in Section 3.3Error! Reference source not found. below) through which we collect automatically, via cookies and similar technologies, Personal Information. A cookie is a small data file, which stores certain information on the browser or hard drive of your computer or your mobile device and which will allow us to distinguish you from other users, enable automatic activation of certain features, improve your user experience and other capabilities and prevent fraudulent or abusive use of the Website.

We use essential and analytics cookies to collect the following information:

• <u>Usage information</u>: about your interaction with the Website, such as what you access, what you click on, the frequency of access, and how much time you spend on the Website.

- <u>Device information:</u> about the device you use to access the Website, such as hardware model, operating system, type of browser and device preferences.
- <u>Location information:</u> your location, which may be determined through your IP address.

We use this information to: (i) track you within the Website; (ii) enhance user experience; (iii) conduct analytics to improve the Website; (iv) prevent fraudulent use of the Website; and (v) diagnose and repair Website errors, and, in cases of abuse, track and mitigate the abuse.

- Most devices and browsers will allow you to erase cookies from your device's hard drive, block acceptance of cookies, or receive a warning before a cookie is stored..
- Particular cookies to note on the Website include:
  - We use **Google Analytics** to help us understand Visitor behavior on our Website, including by tracking page content, and click/touch, movements, scrolls and keystroke activities. In doing so, Google Analytics may set cookies on your browser, or read cookies that are already there. Google Analytics may also receive information about you from applications you have downloaded that partner with Google or if you browse our Website while being logged into other Google services to which you have subscribed separately. We do not combine the information collected through the use of Google Analytics with Personal Information. Google will use and share the information collected through Google Analytics in accordance with its <u>Terms of Service</u> and <u>Privacy Policy</u>. You can refuse our Analytical cookies through the cookie banner on the Website. To opt-out, you can download the Google Analytics opt-out browser add-on.

### **The Legal Basis for Processing Personal Information**

We will not use Personal Information about you unless there is a legal basis for such use. The legal basis on which NBA may be able to process Personal Information is as follows:

- you consent to our processing of Personal Information about you for one or more of the purposes listed below;
- Processing the Personal Information is required in order to take actions based on your request;
- Processing the Personal Information is necessary in order to fulfill a legal obligation that applies to NBA;
- Processing the Personal Information is required for fulfilling legitimate interests of NBA or a third party.

It is hereby clarified that the legal basis for processing Personal Information may differ according to the laws applicable to the processing.

#### **Transfer to Third Parties**

You hereby acknowledge and provide your consent, that in connection with the purposes set forth in this Privacy Policy, We may share and/or otherwise transfer the Personal Information to other third parties, as follows:

- Third party service providers and subcontractors which assist us in the on-going operation of the Website, including (without limitation) for storage or hosting of the Personal Information, assisting us in operating and maintaining the Website, marketing providers, PR agents and email distribution systems;
- To take any action in any case of dispute involving you with respect to your usage of our Website, to defend our rights and prevent fraud;
- We share your internet and other electronic network activity information with third party analytics providers that conduct analytics on our Website;
- In connection with a merger, acquisition, reorganization, assignment, consolidation, transfer, sale, or other disposition of all or any portion of our business for the purpose of facilitating and completing the transaction. We would share Personal Information with third parties if we undergo bankruptcy or liquidation, in the course of such proceedings;
  - We may need to disclose Personal Information in response to lawful requests by public authorities or law enforcement officials, including meeting national security or law enforcement requirements.
- We may also share anonymized and aggregated information in public reports or for general research and commercial purposes, like marketing, with third parties, including our clients.

# **Transfer of Personal Information Outside Your Territory**

We may store, Process or maintain your Personal Information in various sites worldwide, including through cloud-based service providers with data storage in the US. Where applicable, by using the Website, you hereby provide your consent to the transfer of your Personal Information to countries outside your state or country in which the level of data protection may not be as protective as the level in your country.

# **Rights regarding Personal Information**

We will act in accordance with the applicable law, in order to comply with your request.

We may retain certain Personal Information as deemed required by us in accordance with applicable laws, or for legitimate business reasons, for the duration as required under the applicable laws. In addition, we may delete any Personal Information pursuant to our policies, as in effect from time to time.

# **Information Security**

We use a variety of methods to try to protect the Personal Information from loss or unauthorized use or access when it is in our possession or control, including reasonable technical and organizational measures that restrict access to the Personal Information which comply with common industry standards. However, we do not promise or guarantee that any Personal Information will be absolutely protected from unauthorized disclosure or use.

We also regularly monitor our systems for possible vulnerabilities and attacks, and regularly seek new ways and for further enhancing the security of our Website and protection of our Visitor privacy.

You should take steps to protect against unauthorized access to your passwords, phone, and computer by, among other things, signing off after using a shared computer, choosing a robust password that nobody else knows or can easily guess, and keeping your log-in and password private. You should take steps to protect against unauthorized access to Personal Information stored on your devices.

### Retention

We may retain Personal Information for as long as necessary to support the collection and the use purposes under this Policy and for other legitimate business purposes, unless retention is reasonably necessary to comply with our legal obligations, meet regulatory requirements, resolve disputes, or prevent fraud and abuse. We may store aggregated non-Personal Information without time limit.

#### Children

The Website is designed for the use of adults (18 years or older) and is not intended for minors.
